**CALIFORNIA WATER PLAN UPDATE 2009  
2009 REGIONAL WORKSHOP ANNOUNCEMENT**

The Department of Water Resources, in cooperation with 20 other State agencies, invites you to participate in series of regional public workshops to gather and share information about the Public Review Draft of California Water Plan (CWP) Update 2009. The CWP is California's strategic plan for water and covers topics such as water uses, water supply, water quality, regional conditions, regional water planning and flood management, and options for improving water management.

Representatives of: water agencies and associations; local, state, and federal governments; California Native American Tribes; watershed and community groups; conservancies; and the public are strongly encouraged to attend.

Each workshop is specific to a particular hydrologic region or area of California. The workshops will highlight the Public Review Draft for Update 2009, along with the Regional Report for the area, and other Statewide water-related initiatives. Specific input will be sought regarding:

- public comment on the Public Review Draft of Update 2009
- local and regional issues, activities, and water management strategies
