

## **Transition Services Questions & Answers**

As of February 9, 2009

Transition services information is designed to assist permittees in finding resources to remove their personal property from Federal lands and relocate trailers/mobile homes to non-Federal property in the Lake Berryessa area or elsewhere. Transition services do not include any funding or financial assistance from Reclamation.

**1. Who owns the land upon which my trailer/mobile home sits?**

The Federal Government owns the land. The concessionaires are contractors to the Government and provide certain types of services to the public at Lake Berryessa. The concessionaires have no ownership of the land upon which they conduct their business; the land is simply assigned to them for their use during the term of their contracts.

**3. Why do I have to move my trailer/mobile home?**

Through the Record of Decision dated June 2, 2006, Reclamation has re-defined the development and management of visitor services (commercial and non-commercial) to support traditional, short-term, non-exclusive, and diverse outdoor recreational opportunities. This decision requires the permanent removal of all privately owned trailers, mobile homes, and other property from the Federal lands.

**4. I've heard that the trailers/mobile homes probably won't really have to be removed for at least 5-10 more years, if ever. Is that true?**

No. The concession contracts expire on the dates listed above, and pursuant to the Record of Decision dated June 2, 2006, all privately owned property must be removed by those dates. Any privately owned property left on site after the above dates may be considered in trespass on Federal lands.

**5. Are the concessionaires going to let me know when I have to move?**

Yes. For the contracts that expire in 2009, you should have already received a notice from the concession contractor that provides a removal date.

**6. I understand that the permittees are supposed to get a 1-year notice before having to vacate their assigned sites, but could that be changed to a shorter timeframe?**

Yes, under certain circumstances. However, as it relates to the Record of Decision, the concession contractors must issue a 1-year notification to permittees before they must vacate their sites (Lake Berryessa Operational Policy 14, Section E.1.(g)(1)). After a change of land use for the resort has been approved by the administrative agency, the concessionaire shall give the permittees 1 year's written notice of termination of the permit.

**7. What steps do I need to take to remove my personal property?**

Reclamation environmental specialists performed an environmental assessment of each site at Lake Berryessa pursuant to the National Environmental Policy Act of 1969 (NEPA) and determined that all the trailers/mobile homes within the concession areas are environmentally cleared

for removal. Therefore, permittees or concession contractors are no longer required to complete a project proposal and wait for Reclamations approval for the removal of personal property. If you are unsure if your unit has been cleared, please contact your concession contractor or Reclamation's Lake Berryessa Concession Office at 707-966-2111, x141. Effective immediately, the process for notification and removal is:

1. Notify the concession contractor in advance of your scheduled removal date pursuant to your permit.
2. The concession contractor will issue you a Project Decision Page with a list of stipulations to be followed during the removal.
3. The concessionaire will notify Reclamation using the "Trailer Removal Notification" form.
4. Reclamation will monitor the removal process to ensure removal stipulations are adhered to.

No other approval is required for you to begin arrangements to remove your trailer/mobile home and all associated personal property.

**8. Must I pay 1 year's rent for a boat slip or trailer site that I intend to vacate in less than 1 year?**

No. Any fees for dock slips and long-term sites should only be paid for the amount of time authorized in the rental agreements, not to exceed the contract expiration date.

### 11. Do I need a permit to move my trailer/mobile home?

Possibly; the need for a permit depends upon the size of the unit. A transport permit is required to move a mobile home on County or State highways. The type of permit(s) that will be required will depend on where the trailer/mobile home is to be moved. Trailers meeting certain size requirements do not need a permit but will need appropriate DMV licensing (such as travel trailers).

### 12. My trailer was built before a certain year, so by law it can't be towed on California roads, right?

According to the California Highway Patrol and Department of Motor Vehicles, transportation permits are issued regardless of the age of the unit. The vehicle may be inspected by the CHP for safety before a permit can be issued and the trailer transported.

### 13. How do I get a transport permit?

Generally, the contractor you hire to transport your unit will acquire the necessary permits. You may acquire your own permit(s) through these permitting agencies:

**16. Do I have to use a specific contractor to remove or dismantle my trailer?**

No. In fact, we have provided a list of contractors who have expressed an interest in removing trailers within the concession areas. You are free to contract with anyone; however, be advised that the contractor you choose should be licensed and bonded. The list we have provided is not all-inclusive, and we do not endorse any single contractor.

**17. Is it true that only hand tools are allowed to be used to remove or dismantle a trailer?**

No. The provision for the use of hand tools only applies in taking care when removing property that is in close proximity to trees or vegetation that could potentially be damaged during the removal process. The only other caution is not to use heavy mobile equipment that could significantly damage the environment during transport in and out of the concession area, such as mobile cranes with tracks vs. wheels. Almost any type of equipment or tool can be used as long as no more than minimal ground disturbance occurs. If you are unsure, please contact Mr. Dan Kolda, Concession Manager, at 707-966-2111 x141.

**18. Will the Federal Government pay to move my trailer/mobile home?**

No. Specific Congressional authority and appropriations would be required before Reclamation could provide funds to relocate private trailer/mobile homes. The Visitor Services Plan's Record of Decision does not propose to request authority or appropriations for this purpose.

**19. I heard I'm covered by the Federal Relocation Act (FRA) and could get money from the Government for the removal of my trailer. Is this true?**

No. The Department of Interior Solicitor's Office determined that the FRA does not apply at Berryessa.

**20. Am I responsible for the removal of the cement pad the trailer/mobile home sits on and the decking surrounding my space?**

Possibly. Each trailer site is unique, and the removal criteria will differ from site to site. A determination will be made on what must be removed at your specific site once the removal plans are finalized.

**21. Am I responsible for the removal of hazardous material and waste at my site?**

Yes. Reclamation ultimately holds the concession contractor responsible to ensure all hazardous material and waste is properly handled and removed from the concession area. The concession contractor in turn has the authority and responsibility to ensure that the permittee complies with any removal requirements. All hazardous material and waste must be handled or disposed of according to applicable Federal, State, and local laws.

## Transition Services Questions & Answers

As of February 9, 2009

### 22. Where can I take hazardous materials and waste?

First, check with your concession contactor to determine what is considered hazardous waste, hazardous material, or recyclable material and how to properly handle and dispose of each. Recyclable material can be brought to the local recycling center at Lake Berryessa by calling 707-966-2111. The only materials accepted at this location are oil, oil filters, latex paint, antifreeze, and batteries.

### 23. Will the concessionaire allow me to sell my trailer/mobile home in the resort?

Currently, sales are permitted in all resorts except Pleasure Cove Marina; however, this may change as the end of the contracts draws near. There are certain requirements, such as a DMV Bill of Sale and a disclosure statement, which must be signed by all parties. Reclamation requires that any sales taking place must include a removal requirement.

### 24. Trailer Donations

The Hoopa Tribe is looking for donated mobile homes for tribal members. The tribe is willing to pay for the removal and transport of the units.
