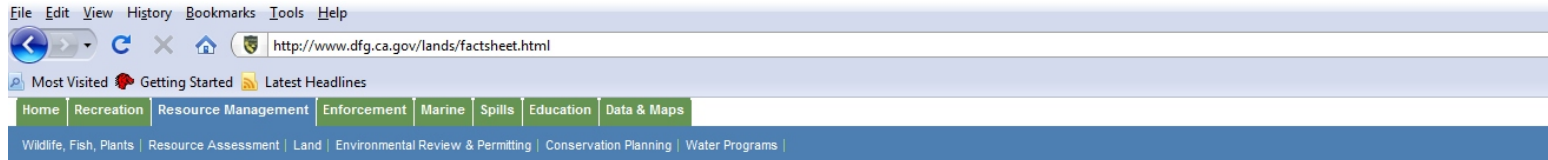


F&G lands and uses. Of over 1 million acres in California managed by F&G, only 5,272 acres are open to public access. F&G owns 617,562 acres "in fee title". This means LESS THAN ONE PERCENT of property owned by F&G provide public access. The rest is under leases, easements or management agreements. Clearly, if its owned by F&G (a governmental agency supported by tax monies) the general public is not welcome on the land. Why are Californians willing to pay taxes to keep themselves off California-owned lands?
